Subject: 2010/11 campaign final report

Our objective this year was 6 candidates to fill 3 opening positions. Five applications were turned in, accepted and included on the ballot. Activities of our 6 member team included placing many posters around the park, Vista Views and GV7 presence, communication at various gatherings and numerous personal contacts. Approximately 50 individuals were approached regarding a position on the board. Action for the year concluded with facilitating the Candidates Forum. Attendance at that meeting was disappointing, with a count of 190.

Our thanks to Jan Miller, Larry Martin, Elaine Olson, Arvella Taratuta, Pat Alsup, Arnie Dickenson and Lance Harvey, Board Liaison, for their active support. Also, thank you to our committee members Adele Finneman, Marlene Goulet, Lee Harber, Phil Parsons and Connie Teghtmeyer.

Two positions on the Board will open next year and we plan to retain our committee for that effort, with an objective of at least 4 candidates. We welcome and encourage ideas to enhance our effectiveness.

This year, as usual, we encountered reluctance to serve on the Board due to actual and perceived significant time commitments and occasional stressful situations. There appears to have been progress made in those areas due to recent positive action and communication from the Board. Golden Vista's challenge for next year remains the same i.e., to communicate the responsibility of being a Board member as interesting, challenging, vital, and rewarding. A reduction in personal time required, and more visible signs of support and appreciation of the Boards work by the GV general community would definitely help in creating more interest. With excellent administrative documentation now in place, great committees, and a skilled Resort Manager, perhaps the positive side of being a Board member will be more apparent.


